National Lottery Community Fund have announced the closure of **COMMUNITY LED** and **IMPROVING LIVES** funding streams **Deadline 30 September 2022**

The National Lottery had planned to review their main funding programmes in 2020 but had delayed that to ensure all their funding remained available throughout the peak of the COVID pandemic.

They have now started the process of reviewing their funding on offer and developing new programmes which will ensure the best use of National Lottery funding to support communities to thrive in future.

As part of this work, they will close Community Led and Improving Lives programmes to applications from Friday 30 September 2022 and launch the new portfolio in early 2023.

National Lottery **Awards for All**, **Young Start** and **Scottish Land Fund** are not part of this review and will remain open to applications.
