ARTS AND CULTURE

1. Scottish Clans & Historical Figures Event Fund

The Scottish Clans & Historical Figures Event Fund supports the growth of events taking place in Scotland that publicly celebrate clans, recognised families and historical figures using their stories and legacy to bring communities together. For Round 7 the fund has been relaunched under its new name 'Scottish Clans & Historical Figures Event Fund', expanding it to accept applications from events that celebrate both clans and/or great Scots internationally recognised for their historical significance. Strong applications will appeal to locals and visitors alike, attract a diverse audience through accessible programming and provide meaningful opportunities to engage with Scottish clans and/or history makers.

2. Tasgadh – Small Grants for Traditional Arts

Tasgadh is a fund devolved from Creative Scotland, managed by Fèisean nan Gàidheal and open to organisations and individuals. Tasgadh is designed to provide support for traditional artists and organisations to create, perform, tour and showcase work. The fund can also support professional development and learning projects. Tasgadh cannot support the purchase of equipment nor can the fund be used to match other Creative Scotland funds.

3. British Film Institute - Audience Fund

The Audience Fund is an open access, flexible fund which is designed to support a range of audience facing activities (such as film festivals, distribution releases, multiplatform distribution proposals, touring film programmes, large scale and ambitious film programmes). All proposals need to meet the objectives of the Audience Fund to increase audience choice and audience engagement across the UK, and have the potential to engage new and diverse audiences including a focus on 16- to 30-year-olds.

4. John Ellerman Foundation - Regional Museums and Galleries Fund

Funding is available to help strengthen regional museums and galleries in the UK by helping organisations to enhance and sustain curatorial development to attract a broader public. They are keen to fund work which has a legacy within and beyond the organisation, particularly applications which enable new ways of working both for established curators and those just starting out or ensure organisations are able to safeguard and advance curatorial skills through a time of development or change.

5. EventScotland – National Events Programme

Funding of £4,000 - £25,000 is available to support sporting and cultural events which take place out with the cities of Edinburgh and Glasgow and drive domestic tourism within Scotland. It is a development programme and therefore does not provide long-term or core funding. It is designed to support additional elements or new activity specifically intended to strategically grow events.

6. Funding for Museums to Purchase Equipment

Independent accredited museums in Scotland can apply for grants to purchase small equipment. This can include items such as ICT, audio-visual, environmental monitoring or collections care equipment. Organisations can apply for £300 to £600 (up to 100% of total purchase costs). The funding is being made available through the Museums, Galleries Scotland Purchase Fund.

7. Creative Scotland Open Project Funding

This fund is run by Creative Scotland for artists, groups, and creative organisations who are looking to apply for money to support them on their artistic or creative projects. Anyone based in Scotland can come to Creative Scotland with their ideas, and this fund will support a wide range of things, from small one-off events to longer programmes of work that can last for up to 2 years. The types of things that this fund will support include:

- Projects which are about helping an artist to develop their skills
- Projects that create something new and high quality, in any art form
- Projects which are aiming to present high quality work to audiences, or projects which try to develop and reach new audiences for the arts
- Projects which encourage more people to take part in artistic and creative activity.

Funding of £1,000 - £150,000 is available.

8. Paul Hamlyn Foundation

PHF is interested in ensuring that a wider and more diverse group of people have access to quality artistic practice. They want to use their funding to support organisations to test, implement and develop ambitious plans to widen access to and deepen participation in the arts. It will not be enough to simply increase numbers – their emphasis is on addressing inequalities of opportunity and creating space to step back and look at the systemic problems preventing participation. They want to help organisations to build stronger evidence about what works so that they can improve practice and achieve greater impact. They will consider applications for:

- New ways of working, or work with new audiences and participants that aim to uncover alternative models
 of engagement together with a strong commitment to learning about these approaches and sharing your
 learning
- Work that involves any of the following: crafts, dance, design, digital arts and media, film, literature (including creative writing and poetry), music, opera, photography, theatre, the visual arts, and cross-arts practices
- Work that is focused on improving access to the arts as a social good in itself, promoting enjoyment, increased attendance and participation by people facing disadvantage and inequality of access
- Work that is focused on increasing arts access for people who may face barriers to participation due to
 disability or a health condition. Work that uses access to and participation in the arts to promote social
 justice (e.g. by achieving outcomes such as personal development, employability, educational attainment,
 social development, community cohesion, well-being, etc.)
- Work that develops excellence in participatory practice
- Work that supports organisations to embed digital solutions in widening access and participation in the arts.

BUSINESS AND ENTERPRISE

9. Carbon Trust Green Business Fund

The Fund is expected to help between 1,000 and 2,000 small businesses to deliver new energy efficiency projects. As part of the service, the Carbon Trust is also offering energy saving training, cost saving assessments, implementation advice, and capital support for the installation of energy efficiency equipment. The programme has an overall budget of £7 million. Eligible companies can apply for a capital contribution to cover up to 15% of an energy efficiency project or equipment replacement cost, up to a maximum of £5,000. This is an increase from the original offering of 15% since April 2016. The programme will fund the purchase costs of energy saving capital equipment that will enable businesses to become 'greener'. Eligible projects could include undertaking energy efficiency upgrades, such as improvements to lighting, heating, ventilation, air conditioning and building control systems.

10. Innovate UK ISCF Future Food Production Systems

With funding from the Industrial Strategy Challenge Fund (ISCF), the UK's innovation agency, Innovate UK (IUK) is providing funding to transform food production systems, improve productivity and sustainability, and help the industry move towards net zero emissions by 2040. Support is available for projects that disrupt the traditional land-based models of food production and aim to determine the transformation of future food production systems. Projects must be ambitious, multidisciplinary and systems-focused rather than dedicated to developing a single technology. Projects should address one of the following:

- The development of new, resource efficient, low emission food production systems.
- The technological and other bottlenecks that prevent existing state-of-the-art systems from supplying mainstream consumer markets.

Applicants must also demonstrate how their proposal will meet points one to three of the specific objectives of the Industrial Strategy Challenge Fund's Transforming Food Production challenge:

- Create integrated data-driven solutions to drive primary agricultural productivity whilst driving towards net zero emissions.
- Embed adoption of precision approaches to bridge the productivity gap, strengthening connections between researchers, businesses and practitioners.
- Stimulate the establishment of novel high value production systems to position UK technologies at the forefront of new industries.

To lead a project, the organisation must be a UK registered business of any size. Projects must be collaborative, and involve at least one SME. UK registered businesses, academic institutions, charities, public sector organisations or research and technology organisations (RTO) can collaborate on the project. Up to £20 million has been allocated to this competition. A project's total eligible costs must be greater than £1 million but less than £10 million. Projects must be carried out in the UK. Projects must start by 1st July 2020 and end by 31st March 2023. They can last between 24 and 33 months.

11. Farm Advisory Service

The Scottish Government is encouraging farming business owners and land managers to take advantage of the funding support available to them via the Farm Advisory Service (FAS) to bring in an expert adviser to help them review the strengths and weaknesses of their business and develop a resilience action plan. Support available:

- Up to £1,000 available to fund a business specialist advice report
- No requirement for a prior Integrated Land management Plan (ILMP)
- Funding available until 31 March 2020

The adviser will work with a participating business to establish key performance indicators for financial resilience, analyse enterprise exposure, assess profitability and cash flow, and inspect the 'health' of the balance sheet. In consultation with a business owner or representative, the adviser will identify appropriate resilience action measures that can be taken and develop a practical implementation plan for the business.

CHILDREN AND FAMILIES

12. Kelly Family Charitable Trust

Registered charities that work to tackle family problems or problems facing one or more of its members can apply for grants of between £1,000 and £5,000. Funding is available for both capital and revenue grants as well as grants for core funding and projects-based grants. The funding is being made available through the Kelly Family Charitable Trust which actively encourages applications from relatively new organisations to help them become established. The trust prefers to support charities whose income is below £500,000. However, larger charities with pioneering pilot projects will be considered

13. Children in Need Small Grants

Children in Need Small Grants provide up to £10k per year for up to 3 years to projects working with children and young people of 18 years and under experiencing disadvantage through; illness, distress, abuse or neglect; any kind of disability; behavioural or psychological difficulties; or living in poverty or situations of deprivation.

14. Toy Trust

Founded by the BTHA, the Toy Trust- the industry's charity- exists to raise money predominantly from the toy industry, its suppliers and friends; and distribute the money raised to charities helping disadvantaged and disabled children within the UK and abroad. Toy Trust funds help disadvantaged children and their families to alleviate suffering; support children through awful experiences; encourage achievement through adversity; purchase vital equipment; provide care; bolster existing initiatives; initiate brand new projects; and satisfy basic needs. COMMUNITY FUNDING

15. FCC Communities Foundation

The FCC Scottish Action Fund offers funding to projects through the Scottish Landfill Communities Fund (SLCF). WREN will consider applications across all types of projects included in the SLCF Objects including: land reclamation, community recycling, public amenities and parks, biodiversity and historic buildings. The Board objectives are for FCC Communities Foundation to fund environmentally-friendly projects which meet a proven community need, offer value for money and are sustainable. They expect projects to benefit the natural, social or built environment and make a positive impact on local communities. Funding is now for a maximum of £40,000.

16. Wee Grants for Wee Groups

The Wee Grants for Wee Groups is a six -month pilot scheme that provides support to registered charities with an annual income of £100,000 or less and constituted community groups conducting charitable work in areas that fit within the Robertson Trust's three priority funding strands:

- Care and Wellbeing improving the quality of life for those affected by physical and/or mental health issues and their carers.
- Strengthening Communities increasing the ability and capacity of people and communities to create solutions which address local need.
- Realising Potential developing confidence and resilience in young people, particularly those who face barriers to success.

One-year grants of between £500 and £2,000 are available towards day-to-day running costs such as rent or utilities, project costs, sessional staff and items such as equipment or training materials. Priority will be given to work that aims to reduce inequality and disadvantage. Although applications can be made at any time until the pilot ends, the end date may be brought forward if a higher than expected number of applications are received.

The pilot scheme is expected to run until December 2019

18. Armed Forces Covenant Fund Trust

Grants of up to £20,000 are available for projects that help integrate Armed Forces and civilian communities across the UK, and/or deliver valuable local services to the Armed Forces Community such as financial advice, housing, mental and physical health, employability or social support for serving armed forces personnel, veterans, and their families. The funding is being made available through the Armed Forces Covenant Fund Trust's Local Grants Programme and applicants are expected to have experience and a track record of working with the Armed Forces Community, as well as a good understanding of the issues facing them. The application must be from either a registered charity; a local authority; school; Community Interest Company or an armed forces unit with a UIN. Applicants will need to work with Local Covenant Partnerships (LCPs). These are formed of the public, charitable,

voluntary and business sectors and representatives from the armed forces for each area of England, Scotland and Wales.

19. Local Road Safety Projects

The Road Safety Trust provides funding to public and professional UK organisations, including charities and university departments, for projects that are innovative and will enhance the knowledge and practice of the road safety community. Projects should focus on engineering, infrastructure and technological measures, while recognising the contribution of education and enforcement to these measures. The Trust provides larger, major themed grants which focus on a different topic each year. The Trust is now offering smaller grants to improve road safety at a local level. Eligible projects are pilots/trials, expanding successful trials across a new area, and/or the evaluation of interventions. Projects should have the potential for being brought to scale with the ultimate goal of reducing deaths and injuries both locally and across the UK. Applications are accepted from Local Authorities, Police Forces, Fire and Rescue Services or UK-based registered charities, not-for-profit social enterprises or community interest companies.

20. Weir Charitable Trust

The Weir Charitable Trust supports services and projects run by Scottish-based community groups and small charities who are struggling to secure funds through mainstream funders or who have unsuccessfully explored all the statutory sources of funding. 22. Tampon Tax Community Fund

Local community groups supporting women and girls with issues like period poverty, domestic and sexual abuse, mental health and long-term unemployment can to apply for a share of £3.5 million for their vital work. Groups anywhere in the UK can apply to their local Community Foundation for grants of up to £10,000 and the funding can only be used for projects or services that directly benefit women and girls. Priority will be given to grassroots organisations, organisations working with women or girls facing multiple challenges, user-led organisations and sustainable projects providing long-term solutions. 23. ACHA Community Action Fund

24. SME Leaders Programme

Provided by the Royal Academy of Engineering Enterprise Hub, the SME Leaders Programme supports promising leaders of high-growth engineering and technology SMEs. By improving the skills of these leaders, the Academy wishes to encourage the pursuit and growth of excellence in UK engineering. The aim of the programme is to support the development of leadership skills, through a number of channels:

- A grant of up to £10,000 towards training courses.
- Masterclasses and workshops delivered by senior business leaders held at the Academy.
- Mentoring by an experienced person from the pool of Academy Fellows and partners of the Enterprise Hub.
- One-to-one coaching.
- Public relations support and networking opportunities.
- Travel and accommodation costs.

Leaders of high growth engineering and technology small and medium enterprises (SMEs) in the UK will qualify for assistance.

25. Flexible Workforce Development Fund

The purpose of the FWDF is to provide employers with flexible workforce development training opportunities to support inclusive economic growth through up-skilling or re-skilling of employees. The Fund is in addition to apprenticeship support, access to which is available to all employers in Scotland; and Individual Training Accounts (ITAs), which provide eligible individuals with the opportunity to undertake learning opportunities to develop their skills for employment. The FWDF may be particularly beneficial in addressing skills gaps and training needs of the older workforce.

26. Home Energy Scotland Loan Scheme

The Home Energy Scotland loan helps homeowners make energy and money saving improvements to their home. This interest free loan is funded by the Scottish Government and is currently open to applications. Funding up to £38,500 per home is available to owner occupiers and eligible registered private sector landlords in Scotland. This covers a range of improvements including:

- energy efficiency improvements (such as insulation, glazing and boilers)
- home renewables systems
- connections to an approved district heating scheme powered fully or partially by a renewable energy source
- energy storage systems.

27. Support for Vulnerable Energy Consumers

The Energy Saving Trust has announced that charities in England, Scotland and Wales can apply for funding through the Energy Redress Scheme. The scheme which distribute payments from energy companies who may have breached rules funds projects that support energy consumers in vulnerable situations and making their homes more energy efficient. In addition, up to 15% of Energy Redress funds can support the development of Innovative products and services related to energy. The minimum grant that can be requested is £20,000 and the maximum grant amount varies depending on the size of the fund available. The scheme can fund projects lasting up to two years, can fund 100 per cent of the project cost and can cover revenue and capital measures.

28. Low Carbon Travel and Transport Hubs

Public, community and third sector organisations in Scotland can apply for capital funding through the Low Carbon Travel and Transport Challenge Fund. Funded through the European Regional Development Fund 2014-2020 Programme the Challenge Fund aims to facilitate the delivery of active travel and low carbon transport hubs, as well as paths. A total of £2.48 million is available for projects from the Highlands and Islands (H&I) area and £5.95 million is available for projects from the Lowlands and Uplands (LUPS) area of Scotland. The minimum project size is £250,000.

29. Cycling Facilities in Universities and Colleges

Colleges and Universities in Scotland who are actively working to promote cycling as a sustainable and healthy travel choice for students and staff can now apply for capital funding of up to £25,000. Funding is available to improve cycling facilities and physical infrastructure, such as cycle parking, signage and changing facilities.

30. Support the Adoption of Ebikes and Ecargo Bikes

Grants of up to £200,000 are available to local authorities, public sector agencies, further and higher education institutions, active travel hubs and community groups to support the adoption of e-bikes and ecargo bikes as an alternative to car journeys. The funding which is being made available through Transport Scotland is providing grants of up to £25,000 towards projects that will provide opportunities to trial e-bikes (Category A fund); and grants of up to £200,000 for the purposes of providing large scale fleets of pool bikes, bike-share/hire schemes, and promoting large-scale uptake of e-bikes as an alternative to car and van travel (category B fund).
