ARTS AND CULTURE

1. Creative Producers 2019

Creative Producers is an initiative designed to support emerging producers develop strong creative skills including the ability to generate a project, identify the right talent for it and keep the momentum going through what is often a long development process. Participants will be based in Scotland and have demonstrable professional experience producing work that has had positive industry and/or public attention. You must have at least one feature film project on your slate that would be eligible/or is receiving support through SFTN's Emerging Talent or First Feature Fund. Please note that this programme is designed for producers who are fully committed to flexing their creative muscles and honing their editorial skills. The training will take the format of one full 2-day workshop and four single day workshops between September 2019 and March 2020 in Edinburgh and Glasgow.

2. Finnis Scott Foundation

Finnis Scott Foundation supports horticulture, plant sciences, fine art, and history projects with grants between £500 and £10k to charities and charitable organisations. Grants are eligible to cover capital or revenue expenditure, with preference given to smaller organisations where impact will be significant.

3. Film Hub Scotland

The Pilot Project programme enables Film Hub Scotland members to undertake pilot audience development work to engage and grow under-served audiences with independent British and specialised film. The ambition is that members will then embed learning into their regular programme delivery after the pilot finishes. They will prioritise projects that focus on promoting diversity and increase inclusion, particularly those that engage young audiences (15-30 year olds). Support for projects will be considered up to £5,000. N.B. If you are looking for support up to £1,000 please see our Pitch Pots programme. Support is available for projects taking place from October 2019 – March 2020. Projects must be completed by March 2020.

4. Funding to Support Arts Projects

5. Open Fund For Music Creators

Songwriters, composers, and artists, bands, producers and performers who are writing their own music or commissioning other songwriters or composers can apply for grants of up to £5,000 to support the creation, performance and promotion of outstanding new music in any genre and to enable the UK's most talented music creators to realise their potential. The funding is being made available through the PRS Foundation's Open Fund for Music Creators and can support activities such as touring, music creator residencies, community projects and live performances featuring new UK music, etc.

6. Women Make Music Grants Programme

7. EventScotland – National Events Programme

Funding is available to support sporting and cultural events which take place out with the cities of Edinburgh and Glasgow and drive domestic tourism within Scotland. It is a development programme and therefore does not provide long-term or core funding. It is designed to support additional elements or new activity specifically intended to strategically grow events.

8. Museum Development Fund

Museums in Scotland that are caring for Recognised Collections can apply for grants of £5,000 to £40,000 for projects that will help them to make strategic steps towards becoming more resilient organisations. Grants of up to £60,000 are available for projects relating to those collections. Grants will be awarded for discrete projects that are additional to, or will help the museum to strategically develop core work clear and that have measurable impact for collections, audiences, workforce and/or the museum's sustainability.

11. British Film Institute - Audience Fund

The fund was established to give everyone, everywhere in the UK the opportunity to enjoy and learn from the richest and most diverse range of great British and international filmmaking, past, present and future. Through the Audience Fund there are two types of awards available: Project awards and Organisational awards. Project awards provide grants of up to usually £50,000 to support nationally significant proposals with cultural ambition where the funded activity will grow priority audiences, and offer greater; Organisational awards provide grants of up to £200,000 to support proposals that enable organisations with proven sector experience to offer a range of year-round activity that meets the outlined objectives of the fund. 15. Knowledge Transfer and Innovation Fund

The Knowledge Transfer and Innovation Fund has two aims.

- The first is to promote skills development and knowledge transfer in the primary agricultural sector. This will be achieved through providing funding to organisations to deliver vocational training, coaching, workshops, courses and farm visits designed to develop skills and transfer knowledge.
- The second is to deliver on-the-ground improvements in agricultural competitiveness, resource efficiency, environmental performance and sustainability.

This will be achieved through meeting the running costs of operational groups seeking to implement innovative projects in these areas. Operational groups can be made up of different individuals or organisations within agriculture who are working collaboratively. The scheme will be aligned with the European Innovation Partnership for agricultural productivity and sustainability. This helps form partnerships between farmers, advisers and businesses working on the ground. These operational groups are expected to generate new insights and innovative ideas, as well as mobilising existing knowledge into practical solutions.

17. Backing Youth Ambition - New Support for the UK's Young Entrepreneurs

Almost two thirds of young people have, or would consider, starting their own business but many say a lack of funding and experience is putting them off, according to research commissioned by The Prince's Trust and Lloyds Development Capital (LDC). The two organisations have come together to launch Backing Youth Ambition, an initiative designed to support youth enterprise across the UK. The three-year programme aims to help over 1,200 young people explore and launch their own businesses through start-up grants and additional funding for The Prince's Trust Enterprise Programme. LDC is also providing support through fundraising, volunteering and mentoring activity across its regional offices, employees and investee companies.

18. Funding to Develop Community Businesses

Disadvantaged and under-represented communities that want to develop successful community businesses by issuing community shares, can apply for development grants of up to £10,000 and equity investments of up to £100,000. The funding is available to both new and existing community businesses. The funding is however not suitable for newly formed community groups that are in the early stages of developing a community business proposal. The funding is being made available through the Community Shares Booster Programme. The funding will be in the form of equity held on equal terms with other community shareholders. The programme is run by the Community Shares Unit, a joint initiative between Co-operatives UK and Locality.

CHILDREN AND FAMILIES

19. Families and Communities Fund

The Scottish Government's Families and Communities Fund will run from April 2020 to March 2023, with up to £16m being available annually. The funding is targeted at registered Scottish charities (that are also incorporated) which deliver work of national significance. The fund will support the delivery of activities which contribute to improved outcomes for children, young people and their families through:

- Delivery of prevention and early intervention
- Providing parenting and family support
- Supporting development of and maintaining positive healthy relationships
- Contributing to positive and sustained support for children and young people to achieve their potential under the Getting it right for every child wellbeing indicators (safe, healthy, achieving, nurtured, active, respected, responsible, included)
- Preventing adverse childhood experiences and providing trauma-informed support to people affected.

The Families and Communities Fund will also support Community Learning and Development (CLD) through:

- Prevention and early intervention through youth work and adult learning and community capacity building
- Support to, and delivery of, lifelong, life wide, learner-centred adult learning
- Using asset-based approaches to work with young people, adult learners or with communities to plan and co-design learning or capacity building opportunities

All applications must show a direct link to at least one National Outcome in Scotland's National Performance Framework. The five National Outcomes that are most relevant to this fund are:

- We grow up loved, safe and respected so that we realise our full potential
- We live in communities that are inclusive, empowered, resilient and safe
- We are well educated, skilled and able to contribute to society
- We respect, protect and fulfil human rights and live free from discrimination and
- We tackle poverty by sharing opportunities, wealth and power more equally

20. Grants for Children's Health and Education

Grants of up to £30,000 are available to registered charities for projects that improve education and health for young people in three key areas; Children and young people with disabilities; Children and young people who are sick in hospital; Children and young people who are life limited (requiring palliative care). The Foundation is a small charity and generally will not make awards of over £30,000 (per year) for up to two years. Funding can be requested for one-off projects or for up to 2 years work. Applications from schools and hospitals are welcomed as long as they are made through an appropriate registered charity. Grant applications for up to £5,000 can be approved by the Director, up to £10,000 can be approved by the Grants Committee, and applications for more than £10,000 are recommended to the Trustees for final approval.

21. Henry Smith Charity

From the 3rd of July 2019, schools, youth groups, not for profit organisations and charities will be able to apply for grants of £500 to £2,500 to support recreational trips or holidays within the UK for groups of disabled or disadvantaged children (aged 13 or under). Priority will be given to applications coming from the 20% most deprived

areas in the UK. The grants can cover up to two-thirds of the cost of a holiday or trip lasting one to seven days. The funding is being made available through the Henry Smith Charity.

22. BBC Children in Need Emergency Essentials Programme

The BBC Children in Need Emergency Essentials Programme which supports children and young people up to the age of 18 living with severe poverty as well as additional pressures such as domestic violence, disability or poor health in the family is currently open for applications from referral organisations that will be able to apply for grants on behalf of families or young people. The fund will cover the purchase of critical items such as gas or electric cookers and other essential household items. The referrer's organisation should also be able to administer and supervise the grant on behalf of the BBC Children in Need Emergency Essentials Programme.

23. Funding of up to £5,000 Available to Tackle Problems within Families

Registered charities whose activities support and encourage the family to work as a cohesive unit in tackling problems that face one or more of its members can apply for grants of between £1,000 and £5,000 (but trustees will consider requests for higher amounts) through the Kelly Family Charitable Trust. The Trust will consider both capital and revenue grants. The Trust is happy to support requests for core funding as well as project-based grants, and actively encourages applications from relatively new organisations to help them become established. The three areas of activity that the charity wishes to support are:

- Interventions that support families and help them in ways that prevent the fracture of the family unit, e.g. practical family support, relationship counselling, mediation.
- Families where sexual abuse, physical abuse, domestic violence, alcohol abuse and drug abuse threaten the integrity of the family unit.
- Prisoners and in particular their families, during and after the period of imprisonment.

The trust prefers to support charities whose income is below £500,000. However, larger charities with pioneering pilot projects will be considered.

COMMUNITY FUNDING

24. Funding to Integrate the Armed Forces into their Local Community (UK)

Grants of up to £20,000 are available for projects that help integrate Armed Forces and civilian communities across the UK, and/or deliver valuable local services to the Armed Forces Community such as financial advice, housing, mental and physical health, employability or social support for serving armed forces personnel, veterans, and their families. The funding is being made available through the Armed Forces Covenant Fund Trust's Local Grants Programme and applicants are expected to have experience and a track record of working with the Armed Forces Community, as well as a good understanding of the issues facing them. The application must be from either a registered charity; a local authority; school; Community Interest Company or an armed forces unit with a UIN. Applicants will need to work with Local Covenant Partnerships (LCPs). These are formed of the public, charitable, voluntary and business sectors and representatives from the armed forces for each area of England, Scotland and Wales.

25. Grants for Projects Aiming to Strengthen Communities

The Robertson Trust aims to improve the quality of life and realise the potential of people and communities in Scotland by recognising and responding to need and disadvantage building the capacity and sustainability of charitable organisations to achieve positive change. Priority is given to work that reduces inequalities by responding to identified needs and disadvantage and involves direct delivery of services and activities. Main and Major revenue and capital grants are awarded under the theme of Strengthening Communities with grants supporting work that directly addresses one of the following three themes:

- Reducing health and social inequalities;
- Supporting people and communities to find routes out of poverty;

• Empowering communities.

Organisations registered with OSCR/Charity Commission/Office of the Regulator of Community Interest Companies and Community Interest Companies Limited by Guarantee are eligible to apply. Revenue grants of £500 to £20,000 per annum may be awarded for core or project funding for a maximum of 3 years. Main Capital Awards of £500 upwards are awarded towards the upgrading of buildings, equipment or refurbishment costs to a maximum of 25% of total project costs. Match funding of 30 – 40% of project income should be secured before applying. Major Capital Awards in excess of £250,000 may be made to projects taking innovative approaches with bids going through a two-stage process. Potential applicants are advised to call a member of the Trust's Giving Team to discuss their project before applying. Further information can be found in the Major Capital Guidelines.

27. Armed Forces Covenant Fund Trust

A £3 million specialist pot of funding has been launched specifically to support renovations and improvements to veterans' community centres. Grants of up to £30,000 are available for projects submitted by charities or Community Interest Companies supporting the armed forces community. A small number of grants of up to £150,000 will be made to more complex projects. All projects funded will be for renovations or improvement to community centres already used by veterans.

28. Wee Grants for Wee Groups

The Wee Grants for Wee Groups is a six -month pilot scheme that provides support to registered charities with an annual income of £100,000 or less and constituted community groups conducting charitable work in areas that fit within the Robertson Trust's three priority funding strands:

- Care and Wellbeing improving the quality of life for those affected by physical and/or mental health issues and their carers.
- Strengthening Communities increasing the ability and capacity of people and communities to create solutions which address local need.
- Realising Potential developing confidence and resilience in young people, particularly those who face barriers to success.

One-year grants of between £500 and £2,000 are available towards day-to-day running costs such as rent or utilities, project costs, sessional staff and items such as equipment or training materials. Priority will be given to work that aims to reduce inequality and disadvantage. Although applications can be made at any time until the pilot ends, the end date may be brought forward if a higher than expected number of applications are received.

29. ACHA Community Action Fund

Argyll Community Housing Association Ltd (ACHA) has a small fund from which the Association makes donations to registered charitable organisations which are worthwhile causes and which have some housing connection or a connection to the Aims & Objectives of the Association. 30. Interest Free Loans to Improve Community Spaces

Community organisations that own or manage a building or outdoor space that's used for a wide range of community activities can apply for interest free loans of up to £50,000 to develop their trading activities and generate a more sustainable income. The aim is to generate a regular income that allows community organisations to maintain and invest in community spaces. The funding is being made available through the Co-op Foundation. Organisations based in more deprived areas or who work mainly with more disadvantaged members of the community may also be eligible for grant funding alongside the loan.

31. Trusthouse Charitable Foundation

The Foundation is offering Community Centres in deprived urban communities and Village Halls in remote and economically deprived rural areas the opportunity to apply for capital grants of between £7,500 and £60,000. Grants can be used to fund new buildings; upgrading, renovating or extending buildings; improving or creating outside space (but not car parks). All applicants must have secured 50% of the total cost of the work and have local community fundraising underway. Grants will be made to projects centred on 'community centres' in the broad sense, this may include a church, sports facility or other building which offers a range of activities throughout the week which all the community can access. It is expected that the completed venue will provide a range of activities for all ages and abilities which help to promote community cohesion and address local problems of isolation, poverty, lack of local facilities, transport and other issues of relevance to the area in which the centre is located. SPORT FUNDING

75. Scotland's Sports Facilities Fund

Grants of up to £100,000 are available to support capital projects that create or improve places where people take part in sport and physical activity. The funding is intended for sports facility projects within club and communities, school and education or performance sport environments. Activities should clearly demonstrate an impact on one or both of the following outcomes:

- Participation provide opportunities for people to get involved and participate in sport and stay involved throughout their life.
- Progression provide opportunities for people to develop, progress and achieve success at their chosen level of sport.

Priority will be given to projects where there is a commitment to the following:

- Equalities and inclusion.
- People development.
- Collaboration and impact (applications must show that the community has been involved in the decision-making stages of the proposals).

Grants of up to £100,000 are available to support the following:

- Small Projects with a total project value between £20,000 and £250,000 (including VAT).
- Larger Projects with a total project value over £250,000 (including VAT).

Only capital expenditure costs will be considered, defined as the purchase, upgrade or construction of an asset; costs directly incurred in the process such as related Architect, Quantity Surveyor, Engineer's and Solicitor's fees, as well as planning, building warrant asset purchases or leases fees are included. 76. Grants to Enable Disabled People to Play Tennis

Special schools as well as coaches, clubs, disability groups, associations and individuals can apply for grants from the Dan Maskell Tennis Trust for equipment and specialist wheelchairs to enable disabled people to play tennis. Funding of up to £1,500 is available for groups and clubs and up to £500 for individuals. The Field Studies Council is an independent educational charity committed to raising awareness about the natural world and works through a network of residential and day Centres in the UK to provide outreach education and training. The funding is available to help young people aged 14 - 18 (25 for those with special needs) attend a course who may otherwise be excluded due to some form of disadvantage - health, mobility, deprivation or financial. One free staff/adult place is provided for every 12 young people; additional adults pay 20% +VAT. This includes all equipment, tuition and waterproof hire costs. Food and accommodation are included for residential courses.
